

## A trip for two to the Ozzfest of your choice Contest Rules

### **Who Can Enter**

1. Eligible contestants must be legal U.S. residents of the State(s) of Massachusetts, New Hampshire, Rhode Island, Connecticut, Vermont, South Carolina, North Carolina and Georgia, Kansas, Missouri, Oregon, Washington, New York, California and Louisiana within the boundaries of Orleans, Jefferson, St. Bernard, St. James, Lafourche, St. Tammany, Plaquemines, Terrebone, Tangipahoa, St. John the Baptist, St. Charles, Washington Parishes or, in Mississippi, Pearl River and Hancock Counties.
2. Eligible contestants must be 21 years of age or older as of date of entry.
3. Take Over” banner, then click on the “**A trip for two to the Ozzfest of your choice**” link and then complete and submit the official entry on-line with your full name, mailing address, daytime telephone number, and email address. YOU DO NOT NEED TO BE A MEMBER OF ANY OF THE STATIONS ONLINE CLUBS TO ENTER.

6. Only one (1) entry per email address.
7. On or about June 22, 2010, up to one (1) Grand Prize Winner (subject to confirmation of eligibility and compliance with these contest rules) will be randomly selected in a drawing from among all entries received nationally (see below). ### **Prize**

8. Up to one (1) prize will be awarded in this contest. The verified Grand Prize Winner in this contest will receive one (1) trip for two (2) to see Ozzfest on **one (1)** of the following dates and locations, which must be selected by the Grand Prize Winner no later than June 30, 2010:

20. Odds of winning depend upon number of entries received.

**Other General Rules that Apply to this Contest**

- ineligible entrants prior to conducting the random drawing.
